

CAPITAL CLUB PROGRAM RULES

1. You agree to abide by and be bound by these rules. Use of your Capital Club card means you consent to these rules. If you object to these rules, please return your Capital Club card and we will cancel your membership.
2. You must be 21 years of age or older.
3. Physical valid government-issued personal photo identification required for membership and to redeem Comp Dollars, prizes, gifts, and complimentary or discounts offers. Redemptions also require you to present your Capital Club card.
4. Employees of Dover Downs Hotel & Casino ("Dover Downs") or its parent, affiliated or subsidiary companies are not eligible to participate in the Capital Club program.
5. Participation in the program constitutes your permission to use your name and/or likeness and biographical data in any manner by the Capital Club and its agencies or assignees without further notification, approval or review by you and without any compensation to you.
6. BY ACCEPTING YOUR CAPITAL CLUB CARD OR ANY PRIZE OR GIFT FROM THE PROGRAM, YOU AGREE TO RELEASE DOVER DOWNS, its parent, subsidiaries and affiliated companies and their respective shareholders, directors, officers, employees, agents, successors and assigns FROM ANY AND ALL LIABILITY, INJURY, CLAIM, DAMAGES OR LOSS OF ANY KIND WHATSOEVER ARISING OR RESULTING FROM THE CAPITAL CLUB PROGRAM, THESE RULES, OR THE AWARDING, RECEIPT, ACCEPTANCE, POSSESSION, OWNERSHIP, USE OR MISUSE OF ANY PRIZE, GIFT OR OFFER.
7. Dover Downs will not be held responsible for lost or stolen Capital Club cards.
8. All transactions must be done in person at Dover Downs.
9. Dover Downs reserves the right to terminate complimentary offers, discount offers, or your membership at any time and for any or no reason, at its sole discretion. Membership termination shall result in the forfeiture of all points. Points do not have any monetary value. Without limiting the generality of this rule, termination may result if you are unruly or disruptive, engage in or are suspected of misconduct, violate or attempt to circumvent membership or facility rules, fail to cooperate with security or other casino staff, or are barred from the facility. Dover Downs reserves the right to bar anyone from its facility or to deny a membership application for any or no reason, at its sole discretion.
10. Dover Downs reserves the right to change any of these rules or terminate the Capital Club program at any time with no prior notice.
11. Program benefits are non-transferable and are not valid in conjunction with any other program.
12. Rules may vary with specific promotions.
13. Membership cards have no expiration date. However, points accumulated may be expunged if there is no activity for a period of twelve (12) months.
14. To earn points for slots, insert your Capital Club card into a card reader attached to a slot machine. While the card is in the reader and the slot machine is being played, you will accumulate points.
15. To earn points for table games, give your Capital Club card to the dealer or floor supervisor each time you sit at a table, prior to your first bet.
16. To earn points for horse racing, give your Capital Club card to the ambassador each time you place a bet on horse racing.
17. You shall not lend your Capital Club card to others and shall not play with other members' cards.
18. Any discrepancies with the Capital Club program must be reported to the Capital Club within a 24-hour period.
